Michael West reported on his participation and attendance in activities, such as serving as a judge for the holiday door decorating contest at the Village; continued discussions with the SARB team that included the schedule, future meetings, and process evaluation; publication of the Annual Report by Communications and Public Relations Director Alissa Maas; and the Administrative Services holiday potluck. Michael provided an update on the Governor's Budget Proposal that appeared to protect K-12 education, and on new laws for 2024 including:

AB 446 – Places cursive writing back into curriculum.

AB 579 – Requires all school buses to be zero-emissions by January 1, 2035.

AB 1228 – Sets a \$20.00 minimum wage for national fast-food chains by April 1, 2024.

SB 760 – Provides at least one all-gender restroom on each school site by 2026.

SB 765 – Changes STRS post-retirement from 50% to 70% of median final compensation.

#### 10.1 Community College District Territory (standing item)

Michael West reported on upcoming meetings, including a January 12, 2024, open door meeting to introduce WCC President Lizette Navarette at the Lake County Campus, and a meeting of the Adult Consortium on Friday at WCC.

#### 10.2 Facilities Update (standing item)

Michael West provided a brief update on installation of the portable classrooms at the Village.

#### 10.3 LCAP Update (standing item)

Educational Services Assistant Superintendent John Ithurburn reported that the 2023-24 LCAP Annual Update Mid Term Report will be presented to the Board during their February meeting.

#### 10.4 Universal Prekindergarten (standing item)

Children's Services Director Vicki Markss reported on UPK activities, including updates on Quarterly Report submittals; on revised CDE Preschool Transitional Kindergarten Learning Foundations; and on collaboration with Yuba COE to support implementation of UPK in Colusa County that will include professional development, workshops, and ongoing support.

Discussion was held on tabling the 2024-25 Liaison Assignments until more members can participate.

Ed Conrado/Moved, Cristy Edwards/Seconded, and the motion carried three ayes, two absent (Brenda Miller and Serena Morrow) to table setting the 2024-25 Liaison Assignments until the February 14, 2024, meeting.

## 11.1 Accept 2022-23 Financial Audit Report, Presented by James Marta & Co. – Jesse Deol, CPA, ARM

Jesse Deol presented the Independent Auditor's Report for the fiscal year that ended June 30, 2023, highlighting the Governance Report, the Audit Report, and Scope of Engagement. He began with the Governance Letter and talked about its purpose and its opinion, which was clean and unmodified, saying that it is the best opinion an auditor can give. Jesse reported on the Qualitative Aspects of Accounting Practices, Audit Procedures, and Results of the Audit (no issues and no findings, nor deficiencies noted). He went on to discuss financial statements in the Management Discussion and Analysis, Summary Statement of Net Position, Summary Statement of Activities, 2022-23 County School Services Fund Revenues and Expenses, Financial Trends and Analysis that indicates a reserve of 5% and a three-year downward trend of long-term debt and ADA, and Comparative Statements of Net Position that indicate CCOE has a healthy net position (\$9.4M). He also reviewed the Summary Statement of Activities that includes the pensions liability, County School Services Fund Revenues and Expenses, Financial Trends and Analysis that indicate CCOE is meeting its reserves, and Average Daily Attendance. Jesse spoke about the three corresponding communications, or reports, in which no matters were reported. Despite the \$5.1 Million deficit due to the change in the net pension liability, he said that the financial condition of CCOE is improving while benefitting from sound financial management decisions. Jesse thanked CCOE's fiscal team for their assistance.

Ed Conrado/Moved, Madison Martin/Seconded, and the motion carried three ayes, two absent (Brenda Miller and Serena Morrow) to accept the 2022-23 Financial Audit Report.

11.2 Approve Board Resolution 23/24-04 Authorizing Application for State of California Department of Social Services Continued Funding Application
Vicki Markss reported on the resolution, which is needed to apply for State of California Department of Social Services Continued Funding Application. Vicki explained that the CDE needs to be included, and that the title needs be changed as follow: Approve Board Resolution 23/24-04 Authorizing Applications for State of California Department of Social Services and California Department of Education Continued Funding Application

Cristy Edwards/Moved, Madison Martin/Seconded, and the motion carried three ayes, two absent (Brenda Miller and Serena Morrow) to approve Resolution 23/24-04 with the title change to Authorizing Applications for State of California Department of Social Services and California Department of Education Continued Funding Application.

#### 11.3 CCBE Transition to CSBA Region 14

Discussion was held on the CCBE to CSBA transition moving forward, and on whether dues will increase. Tina Maxwell reported that Serena Morrow attended a Region 4 County Presidents meeting on Monday and the Board would like Serena to report on the meeting during the February Board meeting.

#### 11.4 Al in Education Presentation

Alex Evans presented information on Artificial (or as he said Automated) Intelligence, saying that these are pretty much compounded searches or automated discussions. Alex demonstrated examples of AI inquiries and responses. Discussion was held on reference sources, determining source credibility, and the need for cross references. Discussion was also held on key issues in education besides plagiarism, and on overcoming fears of AI just like past fears of internet in the classroom.
