CLASS TITLE: SPEECH AND LANGUAGE SPECIALIST

BASIC FUNCTION:

Under the direction of the Assistant Superintendent of Special Education/SELPA, screen, assess, and provide specialized speech and language services to children and young adults who qualify for services as established by State standards; participate in developing and implementing Individual Educational Plans (IEP's) for students who qualify for Designated Instructional Services (DIS).

REPRESENTATIVE DUTIES:

Provide speech and language screening for children and young adults ages 0 to 21; utilize age-appropriate standardized and non-standardized screening and assessment tools. *E*

Conduct a full-scale speech and language assessment of referred students for initial evaluation and triennial reviews. Complete concise and valid assessment reports, which include diagnostic information and treatment recommendations. *E*

Develop IEP's and participate in IEP meetings and consultations to provide assessment information to teachers and parents. Provide written reports of assessment of current communication skills and recommendations for future instructional needs. *E*

Prepare and maintain a variety of related records and reports, such as IEP forms, diagnostic information, daily speech notations, attendance registers, notes on parent/professional contacts, annual review summaries, and progress reports. *E*

Provide individual and small group therapy to eligible students; schedule caseloads, plan lessons, and provide periodic whole class language experiences. *E*

Participate in in-service training sessions, departmental meetings, district and county staff meetings, parent conferences, Student Study Team meetings, and in consultations with other educational staff and professionals in related fields. *E*

Utilize technology to enhance speech and language services. *E*

Supervise Special Education Instructional Assistant. E

Perform related duties as assigned.

Communicate effectively both orally and in writing to parents/other educators/professionals in related fields

Maintain records and prepare reports.

Maintain current knowledge of program rules, regulations, requirements and restrictions.
