

# What qualifies a child for the McKinney Vento Program?

Under the McKinney-Vento Assistance
Act, children and youth whose housing
situations fall into one of the following
categories qualify:

- Staying temporarily with other people due to financial hardship
- Staying in temporary housing without permanent purposes
- Stay in emergency or transitional shelters
- Staying in motels, campgrounds, cars, parks, abandoned buildings, or any public or private place not designed to provide adequate housing



### **Student Rights**

Legal Requirement	Homeless Youth	Foster Youth
Enrollment	Required immediately, regardless of lack of documentation, immunizations, etc.	
Immunizations	Must be enrolled regardless of lack of immunization information including Tdap.	
Special Education	Appropriate and immediate placement in classes regardless of records; 30-day review.	
Equal access	Every program or afterschool activity that any other student would qualify for.	
Free and Reduced Lunch	Automatic qualification.	
Partial Credits	LEAs must provide credits based on the amount of time student was present, regardless of whether student completed the semester at the school.	
Grade and Credit Protection	Student maintains grade and credit earned from previous school placement, even if student transfers mid-semester.	
Minimum Requirements for Graduation	Must be considered homeless or foster youth, transfer after the 2nd year of high school, unable to complete local requirements within 4 years or if offered, a 5th and must be informed within 30 days of transfer.	
<b>School of Origin</b> (SB 445- Ch. 289, Stats 2015)	Once permanently house, student may remain until end of the school year (PK-8) or through graduation (9-12th).	When no longer under court jurisdiction, the student can attend for the duration of the school year (K-8) or through graduation (9-12).
Expulsion	10-day notice to liaison for manifestation determination and expulsion hearing.	10-day notice to attorney, educational rights holder, and social worker for extension of suspension, manifestation determination and
