

Colusa County Superintendent of Schools

The County Superintendent of Schools is an elected official who administers the operation of the County Office of Education. Constitutional law designates an intermediate unit - the County Office of Education – between the California Department of Education and the school districts in the County to assure the most efficient use of taxpayer dollars.

The County Office of Education is committed to assisting the local school districts through direct and indirect services, including fiscal management, curriculum coordination, special schools and programs, health services, and coordination of state and federal projects.

The County Superintendent serves as a facilitator in activities between other governmental and service agencies. Resources of neighboring counties are coordinated in an effort to expand all available services.

The Superintendent works with federal and state legislators to assure maximum funding to provide additional service dollars for the children in Colusa County.

As executive officer and ex-officio secretary to the Board of Education, the County Superintendent of Schools administers all policy set by the County Board of Education.

BOARD OF EDUCATION

The County Board of Education is a policy-making body for the Colusa County Office of Education. The Board includes persons elected from five trustee areas representing the whole county.

Responsibilities of the County Board of Education include:

- Budget approval
- Policy development
- Grant approval for state & federal projects
- Inter-district attendance appeals
- District expulsion appeals
- Instructional materials adoption for County Office schools

The Board acts as the County Committee for School District Organization and is responsible for reviewing and recommending proposals for school district unification, boundary changes and transfer of territory.

Board of Education meetings are held the second Wednesday of each month at the County Office of Education. The public is invited to attend, and the meeting agenda is available prior to each meeting.

- Reviews multi-year revenue and expenditure projections to determine school districts' financial solvency.
- Provides AB3 627 audit resolution, oversight, and follow-up.
- Collects and reports ADA (average daily attendance).
- Audits and processes all districts' payments including payroll and vendor payment.
- Acts as liaison between the California Department of Education and school districts.
- Provides technical and financial analysis and support of the financial system.
- Prepares accounting and reporting for State Teacher's Retirement System (STRS), Public Employee's Retirement System (CalPERS), and other payroll related agencies.

First 5 Colusa

In 1998 the California Children and Families Act (Proposition 10) was enacted, increasing taxes on tobacco productions to fund a comprehensive and integrated delivery system to promote early childhood development from prenatal through age 5. This movement has since become known as, "First 5"emphasizing the importance of the first five years of each child's life.

First 5 Colusa Children & Families Commission is governed by five locally appointed Commissioners with representation aligned with the State Ordinance.

First 5 Colusa invests over half a million dollars per year in programs and services that align with four state-wide investment areas: Child Health, Child Development, Family Strengthening and Systems of Care.

INNOVATIVE APPROACHES TO LITERACY

Colusa County Office of Education's "And Literacy for All" initiative was created as a county-wide literacy project to promote bilingual reading and writing skills to all Colusa County residents utilizing mobile technology through Footsteps2Brilliance. This project provides early learners with increased access to high-quality literacy programming and exposure to digital and print books at school and at home. Literacy is promoted in the home through increased family engagement in literacy activities, such as parent training, interactive book reading, and book sharing routines. Literacy is also encouraged in schools and libraries by improving literacy programming and book access, and expanding professional development opportunities for our early childhood educators. Our primary goal is to have all children reading at or above grade level by the end of 3rd grade.

Special Education/SELPA

Colusa County Special Education provides classes, programs, and services to meet the needs of students, birth through 22 years, who qualify for services within the four school districts. Special Education programs operate in homes, preschools, school sites, and a communitybased transition class. Classroom instruction is provided by teachers with specialized teaching credentials. Students are served in general education settings, with special education support, as designated by an Individualized Education Plan (IEP).

Specialized services include speech and language, counseling, adapted physical education, physical and occupational therapy, as well as programs for visually imhearing impaired and orthopedically paired, impaired infants. SELPA also oversees the Workability program, which prepares junior high and high school special education students for the world of work. It provides pre-employment training and placement in jobs in the community. Our mission is to teach skills and provide connecting activities that will prepare our students to "Take Charge of Their Futures." We do this using an integrated transition curriculum that teaches students to Get a Plan, Get a Job, and Get a Life.

EDUCATIONAL SERVICES

Tobacco Use Prevention Education (TUPE)

The Tobacco Use Prevention Education program is focused on reducing youth tobacco use by helping students make healthful tobacco related decisions. We provide instruction and activities that build knowledge, social skills, and other youth developmental assets. We also provide an alternative to suspension programs and a Brief Intervention Program (BIP) that can help assist students with potential substance abuse issues. These programs can be combined with or as an alternative to Out of School Suspension (OSS), In School Suspension (ISS), and other disciplinary actions.

To provide early education and development opportunities that promotes an optimal learning foundation for young children.

Early Learning Programs

High quality learning centers designed to offer daily exploration and individual development across areas of social-emotional, linguistic, cognition, perceptual, motor, and physical Indoor and outdoor environments present development. intentional activities such as math, science, dramatic play, and literacy to prompt positive peer interactions and problem-solving skills. Staff engage young children in predictable daily routines and facilitate play-based learning opportunities through a comprehensive research-based curriculum. Administration for Children & Families and California Department of Education define the criteria for eligibility for subsidized services. Proudly promoting early literacy in partnership with Footsteps2Brilliance. Early Head Start services through weekly home visiting and learning centers. Head Start, State Preschool & Migrant Programs (both part and full day options available).
