Colusa County Elementary Spelling Competition Set for March 21

The Colusa County Office of Education is pleased to announce the return of the Colusa County Elementary Spelling Competition, which is set to occur on Tuesday, March 21 at 3:30pm. Assistant Superintendent of Educational Services, John Ithurburn, will serve as Spell Master, in addition to two guest judges. This year's event will be hosted in the CCOE Education Village Multipurpose Room, located at 499 Margurite Street in Williams, and will be sponsored by the Sutter-Yuba Association of Realtors (SYAOR). The SYAOR has graciously offered to fund this year's competition, in addition to providing travel stipends to our state competitors. The Elementary Spelling Competition is open to all students currently attending fourth through sixth grade at a district school or district-recognized home school program. Two students from each grade level at each school are invited to participate, and competitors will be chosen at the discretion of the districts. The top two winners at this year's Spelling Competition will then be eligible to represent Colusa

County at the California State Spelling Bee on May 13 in Stockton, CA.

Differentiated Assistance Guide for Parents

Communications Department

The California Department of Education (CDE) provides systems of support to Local Education Agencies (LEAs) under Title I of the California Education Code. One system of support that has increased across California from 2019 to 2022 is Differentiated Assistance (DA). DA is provided to eligible LEAs to address identified performance issues, and is individually designed for each county to meet the needs of its students. This support is issued in the form of financial assistance, to address the improvement of at-promise student performance.



The Colusa County Office of Education (CCOE) has received DA funding from the CDE to support Colusa County districts. One of the focused areas of support will be decreasing an issue that plagues not only Colusa County, but all counties across California - Chronic Absenteeism. According to the CDE, Chronic Absenteeism occurs when "a pupil is absent 10% or more of the school days in the school year." In 2019, before the COVID-19 pandemic, 9% of students on average at each Colusa County school district were chronically absent. Post-COVID-19, an average of 22% of students were chronically absent at each school district in 2022. Compared to California statistics, an average of 10% of students in 2019 and 30% of students in 2022 were chronically absent.

One step the CCOE is making towards decreasing Chronic Absenteeism, is to restore the School Attendance Review Board (SARB). This Board will be composed of representatives from various youth-service agencies, to help truant or recalcitrant students and their parents or guardians solve school attendance and behavior problems, through the use of available school and community resources. SARB will be fully operational by the 2023–2024 school year, coordinated by Jennifer Wayman, CCOE's Educational Services Director of Student Support & Outreach.


